TIMETABLE:

Grant requests received at Polaris by **March 1, 2011** and **September 1, 2011** will be reviewed by the Polaris 'T.R.A.I.L.S.' committee by the end of April and October respectively. Notifications will be made no later than 30 days after the end of the month of review.

GRANT GUIDELINES:

Grant funding is limited to a maximum of \$10,000 per request. Organizations may apply for two grants per year. All organizations must be 501c3, 501c7 or non-profit organizations.

If the grant is approved, a Results Report will be required as follow up to the project. In order to be considered for a new Grant, ALL previous Grant programs must be completed with a result/progress report.

Grants will not be paid in full until receipt of a Final Summary Report. One thousand dollars (\$1,000.00) will be held until the final report has been received.

Provide layout, graphics and content – some visual representation of the project that the grant will support. Project funding from other sources is an important criterion considered by the committee. Polaris video footage and photos are available free of charge to be used in creating print or broadcast materials.
